

## REGULATIONS FOR USING THE WEBSITE PPP4KRAKOW.NET (PPP4KRAKOW.PL)

1. The Municipality of Krakow, hereinafter referred to as the Owner, is the owner of the website, on behalf of which the Sports Infrastructure Management Board of Krakow, hereinafter referred to as the Administrator, operates.
2. When using the website, the User accepts the conditions of these Regulations and shall observe them.
3. All rights to information contained on the website and graphic elements (logotypes, pictograms, graphic designs, visualisations) and multimedia (films, photographs, audio files, animations, presentations, etc.) are reserved to the Owner/Administrator of the Website or/and other entitled entities (the Owner/Administrator is the holder of their consent for the use) and are subject to protection resulting from international and national provisions, especially including the Act of 4 February 1994 on Copyright and Related Rights (Journal of Laws of 1994, No. 24 item 83 as amended).
4. The User of the Website enjoys the right to print and download whole pages with information or their excerpts on the condition of respecting copyright reserved by the Owner/Administrator or other entities entitled to such rights (the Owner/Administrator is the holder of their consent for the use of the material).
5. Any part of information contained on the Website cannot be used to commercial purposes, in particular by copying the whole information or part of the information, electronic transmission or modified in any other manner or used without prior written consent by the Administrator of the Website.
6. The Owner/Administrator shall not be responsible for the level of details, updating and completeness of the information contained on this Website and they declare that the content of this Website is collected and updated with due diligence.

Users of the Website are conditionally offered the possibility of downloading files contained in the part "To download", after prior logging into the Website, filling in and sending through the Website the personal data form containing data compliant with the factual state. Filling in the form and choosing the option "I accept the Regulations" is synonymous to accepting the content of the Regulations and confirming the truthfulness of the data and declaring consent to collecting and processing personal data for the needs of the realisation of the project <<"PPP new perspectives" - the creation of an international network of cooperation to promote public-private partnership for Krakow>> in the scope of data contained in the mentioned form (pursuant to the Act on Personal

Data Protection of 29 August 1997, Journal of Laws No. 133 item 883”). Providing access to the mentioned content to the User is possible after the Administrator of the Website’s acceptance, and the Administrator of the Website reserves the right to refuse access to the content to download to certain users without the need to provide the reason for such decision. The Administrator of the Website reserves the right to verify the data provided by the User in the personal form.

8. The Website provides for the possibility to add comments by the Users to the published news. Comments sent by the Users are subject to the Administrator of the Website’s acceptance who reserves the right to refuse publishing the comment without the need of providing reasons for such decision.

9. The Owner of the Website declares that the content contained on the Website is exclusively of informative character. The Owner/Administrator shall not bear responsibility for the User’s using or lack of possibility of using the content of this Website.
